**\*All Memberships are for the calendar year beginning January 1<sup>st</sup> and ending December 31<sup>st</sup> \***

**Family Golf:** Family unit with two (2) or more golfers, with Full Privileges.

**Single Golf:** One (1) golfer, with Full Privileges.

**Dual Membership:** Member of another Private Golf Facility in New York State. Current Geneva Country Club Golf Members will not qualify for this membership.

**Senior Limited Golf:** One (1) golfer. 60 Years of age or older. Weekdays Only Excluding Holidays and you must tee off by 11:00 Am, or make the turn by 11:00 Am for an 18-Hole round.

**Student Golf:** Junior Golfer beginning at the age of 14 and up to age 18; or enrolled in full-time secondary education up to the age of 24. Junior policies and procedures must be followed.

**Social Membership:** Full use of all clubhouse facilities. Have access to all social functions or events. Play golf up to three times a year upon payment of Green Fees, with authorization in advance from pro shop staff.
